Membership Categories

FAMILY MEMBERSHIP: A Family Membership shall consist of an individual (the "Member"), and his or her spouse who resides in the same household, and all unmarried children of the Member who shall be under the age of 25 residing in the household or attending an educational institution on a full-time basis, including any exchange student from a foreign country residing in the Member's household. Memberships within this class shall require capital contribution and entitles the Member to vote at the annual meeting and any special meeting of the Membership

HOUSEHOLD MEMBERSHIP. A Household Membership shall consist of an individual member (the "Member"), along with his or her significant other who may be unmarried but living in the household, and shall include any other persons living in the household related by blood or marriage to the Member or his/her significant other, who are under the age of 25 or attending an educational institution on a full-time basis, including any exchange student from a foreign country residing in the Member's household. Memberships within this class shall require capital contribution and entitles the Member to vote at the annual meeting and any special meeting of the Membership

REGULAR SENIOR MEMBERSHIP. A Regular Senior Membership shall consist of an individual who is 65 years of age or older (the "Senior Member"), which may include his or her spouse. The Senior Member shall pay an Initiation Fee as approved and required by the Board, shall have no equity stock, and shall not be permitted to participate in a payment plan. The senior Member shall pay full annual dues and may bring his or her grandchildren into the Club as guests, by paying guest fees, without any limitation. In addition, any grandchildren of a Senior Member shall be entitled to participate in both the tennis and swim teams. If a grandchild is enrolled on the tennis or swim team, such grandchild shall be exempt from guest fees. Memberships within this class shall have no voting rights and therefore shall not entitle the Member to vote at the annual meeting or any special meeting of the Membership.
